- He imposed his knowledge from phd classes on us. Whatever discussed in the TA section are almost completely departed from what we have learned from the class. I felt like it was not 120B, but 220B class. Abstract terms, derivations, terminologies and skills of linear algebra which are not required become a must for this class. We are overwhelmed by the TA, not the professor.
- he is a really good TA
- He usually replies me back so quick through email!
- I really liked this TA. He was just a great TA and I really felt a contagious enthusiasm for the subject of economics. His Achilles heel is that he is a little too smart. Like he really brought a lot of upper level math into the discussions and sort of assumed many of us were on board with it. I feel pretty confident in my math skills and it was still hard. My suggestion in that regard is to assign extra reading or specific videos to watch that will help bring everyone up to speed on those topics. For example a Khan academy video about basic linear algebra that would fit into our understanding of multicollinearity. I am not saying he should dumb down the math (because I really think it is important to introduce higher concepts that challenge students and prepare them better for Grad school), but I am saying to provide more resources to bridge the gap of our understanding. Like for every hour of things taught in class, have about 2 hours of easier material to get understanding and practice with the material. I am not saying he create the material, just source material already created that would be helpful.

To be fair, this was his first quarter as a TA for this course, and so it was expected for it to be a little rough. He also said in our last discussion section that he will work to improve lecture notes for his sections which I think will accomplish much of what I am asking. And to be very fair, people really didn't go to his office hours so we can't really blame him for all of our difficulties with learning the material if we aren't meeting him somewhere in the middle.

Things that I really enjoyed from him are that his discussion sections really added to our understanding of the material. Too often discussion sections are unnecessary. They just go over problem sets that will be posted anyway, and the TA doesn't provide too much additional to the discussion of the topic.

He also was just a genuine person who cared deeply for his students. Even though he had a bit of trouble explaining to the lower 25% of the class, he tried hard. He also was generous in giving points back on the quizzes.

Alternatively put him in the honors version of this course and let him go at it.

Overall great experience and anything negative people write about him should be viewed in how uniquely enthusiastic and driven he is as a TA. Professor O said that evaluations are sometimes used to "weed out" bad TAs, and he surely is not is that category whatsoever. He just needs a little guidance and nudge in the right direction. Take this from the person who went out of their way to write nearly the limit of a 3000 character response.
